

NATIONAL ENVIRONMENTAL JUSTICE ADVISORY COUNCIL

MDB supported the National Environmental Justice Advisory Council, a federal advisory committee established by EPA to provide recommendations on broad, cross-cutting environmental justice issues. MDB served as an advisor in facilitating valuable discussions with stakeholders about integrating environmental justice into EPA priorities



and initiatives. MDB supported the preparation of the Council's 20-Year Retrospective Report.

REGENESIS PARTNERSHIP FACILITATION AND COMMUNITY-BASED STRATEGIC VISIONING


For 20 years, MDB Senior Vice President Tim Fields has served as the principal facilitator for an ongoing dialogue among ReGenesis, Solvay USA Inc., EPA Region 4, state and local government officials, and other community stakeholders. MDB facilitates discussion among multiple stakeholders regarding the socio-economic and environmental justice issues of a disenfranchised minority, disenfranchised, and low-income community in Spartanburg, S.C., located close to contaminated hazardous waste sites. These efforts have led to leveraging nearly \$300 million dollars in federal, state, local, private sector, and foundation environmental justice investments for the project to benefit the community, including the cleanup of Superfund and Brownfields sites, new housing, a Federally Qualified Healthcare Center, a community recreation center, and other revitalization efforts.
